Description of Project: The Ocean Outfall is located off the coast of Huntington Beach and extends five miles from the shoreline along the ocean floor. A condition assessment of the outfall has discovered corrosion of the threads of the tie-rods which are located across high-thrust joints in the outfall piping farthest offshore. There is also visible cracking in areas of the concrete and in the metal flap gate that if left un-repaired can lead to structural concerns. This project will replace the tie-rods on the ocean outfall in kind, and repair surface cracks in the concrete and flap gate to stop further propagation.
